1. Course Description

How the important macroeconomic factors like unemployment, inflation and deflation changes and how policy authorities react to these changes are explained in this course. By learning these matters, you will be able to respond to a variety of changes of macroeconomic situations.

The course introduces the following topics: (1) Basic knowledge in macroeconomic policies, (2) meanings of unemployment, inflation and deflation, (3) basic idea of economic growth, (4) functions of international finance.
