1. 授業の概要(ねらい)

This course (composed of Development Finance III in the spring semester and Development Finance IV in the autumn semester) deals with development finance issues in Asia. Development Finance IV will discuss finance for infrastructure development in Asia. Especially, this semester focuses on finance for public-private partnership (PPP) projects. Some PPP cases in infrastructure projects are introduced and discussed in classes.

2. 授業の到達目標

This is an introductory course. By the end of Development Finance IV, students will be able to understand the current status and hurdles in applying PPP modality in infrastructure development in Asia. PPP financing will be focused.

3. 成績評価の方法および基準

Grades will be determined by the combination of class participation (60%), which includes attendance, the degree of participation in discussions and the quality of presentations, and the final report (40%).
