## 1. 授業の概要(ねらい)

This course (composed of Development Finance III in the spring semester and Development Finance IV in the autumn semester) deals with development finance issues in developing Asia. Development Finance III will discuss three major themes in development finance, i.e., (i) financial deepening, (ii) financial access, and (iii) financial stability. Current topics related to these themes are also introduced in classes to encourage participating students' discussions in classes. Though the course basically targets for TAEP students, challenging Japanese students and students from Asian countries are also welcome. The course will be conducted in English.

## 2. 授業の到達目標

This is an introductory course. By the end of Development Finance III, students are expected to understand the current status and how the development of the finance sector could contribute in developing countries in Asia towards sustainable development.

## 3. 成績評価の方法および基準

Grades will be determined by the combination of class participation (60%), which includes attendance, the degree of participation in the discussions and the quality of presentations, and the final report (40%).
