1. Course Description

We will discuss how the NPOs and NGOs take root and play what roles in Japan and overseas from the viewpoint of both theory and exercises. We will decide on themes and literature on nonprofit organizations such as NPOs and NGOs according to the intent of the students and will read and discuss them. If the arrangement can be made, two lectures and workshops on practical cases of NPOs and NGOs will be held by inviting external lecturers. In this course, you will acquire knowledge and attitudes on the policy (degree of diploma policy) DP1 and DP2, especially for the Division of Regional Economics and Policy.

2. Course Objectives

By deepening your understanding of the activities of NPOs and NGOs in the regional societies from both the theory and practical perspective, you can acquire the ability to progress ourselves on solving the problems of the regional societies in the present age.

3. Grading Policy

It will be evaluated by 50% of the usual points and 50% of the issues such as the report.
